Our MPJV structure offers the stability of a large organization through a centralized, shared services back office. **As an NHO, Team MakaiDyne can receive set-aside sole source awards up to \$100 million without additional justification and approval, using a simplified acquisition process:**

1. **Decision is reached by Contracting Officer (KO) to sole source to MakaiDyne**
2. **KO issues an Intent to Award letter with project description and sends to MakaiDyne SBA Representative**
3. **SBA reviews project, determines that MakaiDyne is capable of successfully performing the project**
4. **SBA issues letter of acceptance to the KO**
5. **KO informs MakaiDyne, we begin negotiations**
6. **Once mutually acceptable terms are negotiated the contract is awarded.**
